Regulation 1 - Nominations 1.1 **Competition Nominations** Participation in the competition will be initiated by TFV calling for 1.1.1 nominations from interested teams. Team nominations will be accepted by TFV for the 2022 TFV State Cup via 1.1.2 MySideline, at www.touchfootball.com.au/vic. Nomination numbers in each division will be limited by available 1.1.3 grounds/Fields. All other things being equal, nomination preference will be given in order of 1.1.4 registration. Nominations after the closing date will not be accepted. 1.1.6 Players will only be deemed eligible to nominate and participate in the 2021 TFV State Cup if they are: At least 14 years of age Not suspended by TFA, NRLTFV or another TFA affiliated competition. 1.1.7Financial (i.e. not carrying a debt to TFA, NRLTFV or another TFA affiliated competition). A registered TFV player - Have played a minimum of 5 games for their affiliate or club. An online video briefing will be shared to all affiliated in the week before the competition. No responsibility will be taken for any actions undertaken by 1.1.8 team delegates who do not view the briefing. 1.2 **Duty Referee and Nominations** Referees must be provided by affiliates and clubs for the TFV State Cup. 1.2.1 Affiliates must provide 1.5 referees per team entered. The names of these referees must be communicated to the competition 1.2.2 organisers by the closing date of registrations. Failure to provide a list of names and contact information to the tournament 1.2.3 organisers may result in sides being removed from the competition. Referees must be a minimum of a Badged Level 1 Referee. 1.2.4 Team delegates must give notice to the TFV Competitions Coordinator if the scheduled timeslot is not suitable. TFV will then attempt to reschedule a 1.2.5 more appropriate time.

1.3.5	Any decision made by TFV rejecting a nomination is final.
1.4	Team Name Approval
	Each team must nominate a team name for use within the competition on

	Team names considered by TFV at its absolute discretion to be offensive,
1.4.2	defamatory, racist, discriminatory, or otherwise inappropriate will be refused.
	If a proposed team name is refused, TFV will notify the team delegate. The

	name have been chosen.
	If two or more teams nominate the same team name, a team who played in
	the TFV competition in the season immediately preceding the current
1.4.4	competition will have preference and the other team(s) will be required to
	alter their name.

1.4.5	was received first by TFV will have preference and the other team(s) will be

Regulation 2 - Team Structure and Player Registration

2.1	Team Structure		
2.1.1	The structure of each team must comply with Rule 5 of the TFA Rules.		
2.1.2	A maximum of 14 players are permitted to participate in any one match.		
2.1.3	A maximum of 6 players per team may be on the field at any one time.		
2.1.4	A maximum of 8 substitute players are permitted at any one time.		
2.2	Player Registration		
2.2.1	Each team is allowed to register 16 players.		
2.2.2	If an affiliate cannot field a full side in a division from members from their own		
	affiliate, they can enter a combined side with another affiliate. Points earned		
	under Regulation 13.3 for the State Cup will be shared between the affiliates.		
2.2.3	A player registration form must be completed by each player before the Friday		
	before the competition at 12pm. Failure to do so will render the player		
	ineligible to play in the TFV State Cup.		
2.2.4	Any team which plays a player in breach of Regulation 2.2 will forfeit all points		
	that the team would have otherwise been awarded for each competition game		
	in which that player participated. The opposing team will be awarded the		
	match as a win by forfeit.		
2.2.5	Each player participating in a TFV competition must have agreed to the terms		
	and conditions outlined in the TFA Membership and Participation Application		
	and Declaration.		
2.2.6	Players are not permitted to play in sides from different affiliates, unless		
0.07	forming a combined affiliate side.		
2.2.7	Players are not permitted to play in more than 2 competitions per day. TFV		
	will not be able to accommodate any clashes which may occur.		
Regula	Regulation 3 - Payment of Fees		
0.1	Each team nominated to the competitions must pay the nomination fee of		
3.1	\$400 at the time of registration, via MySideline.		
3.2	No invoices will be sent out to teams and affiliates, all entries must be paid for		
	at the time of registrations.		
2.2	Any team which does not pay the registration fee by the Registration closing		
3.3	date will be removed from the competition.		

3.4 TFV has the right to not refund any of the competition fee paid by a team after the start of competition games.

3.5	A team may be automatically removed from the competition if all competition fees have not been paid in full by the due date, unless the TFV Competitions Coordinator, at his/her discretion, provides approval for alternative payment arrangements. If a player/team is unfinancial from previous seasons and/or representative tours or programs, TFV holds the right to forfeit the team or player until financial. Any current/previous team debt that is outstanding from current/previous seasons, the payment of that debt solely lies on the team contact. TFV holds the right to withhold that team contact/s from participating in any TFV competition/tour until that debt is paid.		
Regula	ation 4 - Grading		
4.1	It is expected that the TFV State Cup will be played in the following divisions: Men's Women's Mixed Competitive and Social Competitions will be split into pools if required		
4.2	Teams in the Mixed Competitive and Social divisions must be aligned with an affiliate or affiliates.		
4.3	TFV reserves the right to regrade any team, in any division at any time.		
4.4	If there are insufficient teams in a division to make the running of a division viable, teams from that division will be placed in an alternative division, with a finals match in their division if possible.		
4.5	Decisions regarding grading in any division will be made by TFV and will be final. TFV may at its' discretion choose to grade a division or not, depending on the quality of teams, the number of teams and any other matters it finds persuasive.		
Regula	ation 5 - Finals		
5.1	Where possible, finals will be over 2 rounds, a semi final and a final.		
5.2	TFV reserves the right to alter, change or remove the finals for a competition at their discretion.

6.1	All Division winners will be presented with a winner's medallion.

7.2	Playing Shirt Requirements

	other requirements of Regulation 7 are met.
7.2.4	Playing shirts must bear an exclusive number.
7.2.5	Players may wear other apparel underneath their playing shirt so long as the

Regula	ation 9 - Game Format		
9.1	Subject to TFV Disrupted Games Policy and Extreme Weather Policy, competition games will ordinarily consist of two halves with a half time break. The exact format for the TFV State Cup will be confirmed once team nominations close.		
9.2	The commencement and recommencement of play in competition games will be initiated by the ground controller.		
9.3	The ground controller will be the sole timekeeper for the competition.		
9.4	The referee will start and finish the competition game by the sound of a whistle.		
9.5	The referee/ground controller may alter the duration of a competition game if he/she considers it appropriate.		
Regula	Regulation 10 - COVID19 Sign In Procedure		
10.1	For COVID-19 Contact Tracing purposes, players must sign in to the location of the TFV Junior State Cup by using the QR Codes provided		
10.2	Players must also sign on using the team sheet for their side before taking to the field for their first match.		
10.3	Players must have registered online via MySideline to be eligible to play.		
10.4	Teams that have not had players register online will have their games recorded as a forfeit.		
10.5	If both teams have players that are not registered, the game will be recorded as a double forfeit.		

Regulation 11 - Score Cards		
11.1.1	Competition game results will be recorded as noted on referee game cards.	
11.2	Referee Game Cards	
11.2.1	Each team captain or delegate must agree with the score at the conclusion of the competition game.	
11.2.2	If a team captain disagrees with the score, they must lodge a protest in accordance with Regulation 12.	
11.2.3	If a team captain/delegate disagrees with the score after the scorecard has been signed and entered, barring any evidence otherwise, the result on the scorecard will stand.	
11.3	Delays and Forfeits	
11.3.1	 If a team is not ready to take the field by the time the siren signals the start of the game (assuming the other team is present), the following actions will be taken by the referee: One touchdown is to be awarded for every two (1) minutes the team is unable to take the field (minimum of four (4) players) If a team is later than five (5) minutes, the game is to be declared a forfeit in favour of the team which is present. 	
11.3.2	If a team receives a forfeit, they will receive three (4) competition points (5-nil score line) and have all their registered players receive credits for 'playing' for finals qualification.	
11.3.3	Teams who forfeit a competition game will receive no points (5-nil score line). Players from that team will not receive credits for 'playing' for finals qualification even if they were at the ground when the forfeit was made.	
11.3.4	Any team that forfeits without notice on two occasions may be removed from the competition at the discretion of TFV, with no refund given for playing fees.	
Regulation 12 - Protests		
12.1.1	A team delegate may lodge a protest on behalf of his/her team with the ground controller following a competition game.	
12.1.2	Protests concerning individual refereeing decisions will not be accepted.	
12.1.3	Protests must be lodged within twenty (20) minutes of the conclusion of the competition game.	
12.1.4	 Protests may be lodged in relation to: Specific incident/s in a competition game considered by the team delegate to have fundamentally affected the outcome of the competition game.

Regula	ation 14 - Disclipline
14.1.1	Touch Football Victoria has adopted the TFA Disciplinary Regulations Manual. Please see this manual at www.touchfootball.com.au
14.1.2	These disciplinary powers are to be read and operate in conjunction with TFA 8th Edition Playing Rules.
14.2	Disciplinary Powers
14.2.1	Despite Regulation 14.1.1, the regulations in this area are intended to provide the referee with further disciplinary powers than specified by the TFA Rules.
14.2.2	An appointed referee is the sole person who has the power to discipline a player, official or spectator during a competition game.
14.2.3	A duty referee has the same disciplinary powers as that of an appointed referee.
14.2.4	The referee coordinator will appoint a referee for each competition game. If no referee or duty roster referee is available. The game will be self-refereed which will be decided by the teams involved.
14.2.5	Despite Regulation 14.2.4, TFV does not guarantee a referee will be provided for each competition game.
14.2.6	 During a competition game, a player may be disciplined by the referee if the referee believes: The player has infringed, or attempted to infringe, the Laws of the Game; or The player is reasonably likely to infringe the Laws of the Game; or The player, an official and/or spectator has breached the Code of Conduct.
14.2.7	 A referee may discipline a player by: A warning. A direction to the player to substitute (force sub). A direction to the player to leave the field for 4 completed sets (Sin Bin). A direction to the player to leave the field for the remainder of the competition game (send off).
14.3	Disciplinary Categories and Sanctions
14.3.1	 Warning: At the discretion of the referee, a player may be given a warning for infringing the Laws of the Game, or for behaviour attempting or intending to infringe the Laws of the Game. If a player is given a warning, at the discretion of the referee, a penalty may also be awarded to the opposition team.
