

**NRL Touch Football x DoorDash**  
**WSOO Competition**  
Terms & Conditions

**ELIGIBILITY**

1. The Women's State of Origin Competition (the "Competition") is open only to individuals who participate in affiliated Touch Football Australia competitions within 120km of the Australian Capital Territory. Void where prohibited or restricted by law. The following individuals are not eligible to enter or win a prize: employees, contractors, representatives, agents, directors, and officers of DoorDash, Inc. ("Sponsor") and parent, subsidiary, or affiliated companies, marketing agencies, and any other parties involved in the administration of the Competition (collectively, the "Competition Parties") By participating in this Competition, participants agree to be bound by these official rules ("Official Rules") and by the decisions of the Sponsor in all matters relating to the Competition.

**COMPETITION PERIOD**

2. The competition period runs from 17<sup>th</sup> June 2022 at 10:00am and ends 22 June 2022 at 16:00 p.m.

To the fullest extent permitted by applicable law (including the Australian Consumer Law), Released Parties are also not responsible for problems related to unauthorized human intervention or for technical malfunctions of electronic equipment, computer online systems, servers, or providers, computer hardware or software failures, phone lines, traffic congestion on the internet or any website, or for any other technical problems including telecommunication,

miscommunication or failure, and failed, lost, delayed, incomplete, garbled, or misdirected communications, which may prevent the receipt of an entry or otherwise limit an entrant's ability to participate in this Competition. Released Parties are not responsible for any other errors or malfunctions of any kind, whether network, printing, typographical, human or otherwise relating to or in connection with the Competition, including, without limitation, errors or malfunctions which may occur in connection with the administration of the Competition, the processing of entries, the announcement of the prize or in any Competition-related materials. As a condition of entering, entrants agree (and agree to confirm in writing if requested by Sponsor) that to the fullest extent permitted by applicable law: (a) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, indirect, special, exemplary, or consequential damages and (b) that any and all claims, judgments, and award shall be limited to actual out-of-pocket costs incurred, excluding attorneys' fees and court costs.

#### **LEGAL WARNING**

Any attempt by an individual, whether or not a participant, to deliberately undermine the legitimate operation of this competition is a violation of criminal and civil laws, and should such an attempt be made, sponsor reserves the right to seek damages and diligently pursue all remedies against any such individual to the fullest extent permitted by law.

#### **SPONSOR'S RESERVATION OF RIGHTS**

12. If the Competition is not capable of running as planned for any reason, including without limitation, due to a force majeure event or infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Competition, Sponsor reserves the right, at its sole discretion, to disqualify any individual who is responsible or who tampers with the entry process or otherwise acts in violation of these Official Rules, and to cancel, modify, or terminate the Competition. In the event of cancellation, Sponsor reserves the right to award the prizes in its discretion based on all eligible, non-suspect entries received prior to cancellation. In the event that an entry is confirmed to have been erroneously deleted, lost or destroyed, the entrant's sole remedy shall be another entry into the Competition.

13. Governing Law, Jurisdiction, and Severability: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants' rights and obligations, or the rights and obligations of the Sponsor in connection with the Competition, shall be governed by, and construed in accordance with, the laws of New South Wales, without giving effect to any choice of law or conflict of law rules. By entering, entrants agree to the jurisdiction and venue of the state and local courts located in New South Wales for the resolution of all disputes and agree that any and all disputes shall be resolved exclusively in those courts. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that or any other provision. If any provision of these Official Rules is held to be invalid or unenforceable, such provision shall be struck, and the remaining provisions shall be enforced.

#### **PRIVACY**

14. Any personally identifiable information collected during an entrant's participation in the Competition will be collected by Sponsor or its designee and used by Sponsor for the proper administration and fulfilment of the Competition and as otherwise described in these Official Rules DoorDash's Consumer Privacy Policy.
