Introduction.

This policy outlines the guidelines that will be in place for the selection of ACT Raiders Touch Squads and Teams. This policy should be used as the starting point for selection of all representative teams as it will ensure the selection process is consistent and transparent at all levels and is not compromised in any way.

The aim of this policy is to ensure that selections are independent, fair, and transparent whilst ensuring all aspiring athletes are given a reasonable opportunity to demonstrate their skills and abilities.

Noting that this ACT Raiders Selection Policy is a working document, Touch Football ACT may amend or change any part of these guidelines without notice where deemed necessary.

	The trials and final selection process shall be completed on a date determined by Touch Football ACT.
	Touch Football ACT will appoint a Selection Panel which will be led by the ACT State Manager in the capacity of Selection Chair who will be responsible for the coordination, communication, and arrangements for the process in appointing those members of the selection panel.
	Any disputes in relation to the selection process or decisions of the selectors shall be overseen by Touch Football ACT.
	2 – Selection Panel Appointment
	The Selection Panel will consist of a minimum of two independent selectors, excluding the Chair and the appointed coach.



	the panel Chair prior to the trial dates. Injured athletes must produce a medical
	certificate.
	h) At all times follow Touch Football ACT and/or Touch Football Australia (TFA) Code
	of Conduct.

	i) If an athlete is provided dispensation during the selection period, that player will
	not be denied selection consideration. If members of the Selection Panel and/or
	Coaching Panel can attest to the player's ability, in comparison to others at the
	event, then that player is to be added to the squad for further assessment.
	j) The selected athletes for the team/squad will be notified via email in the first
	instance before teams are released on TFACT website and social media channels.
	k) Confidentiality of all selected players must be adhered to by all Selection Panel
	members, Coaches and Touch Football ACT members involved in the process.

	n)	If suitable replacement players from a squad have been exhausted, Coaches with
		the assistance of the selection panel may call for further EOI's to source players
		from TFACT domestic competitions prior to initiating a player loan.
	Player I	Loan System – NTL and NYC
		- All player loans, where needed, must first be discussed, and approved in full
		by Touch Football ACT in line with all TFA guidelines.
		- Touch Football ACT may at any time deny a player loan request where it
		deems reasonable.
ltem 8 – R	egistrat	ion Process.
	a)	All registrations of those athletes who have accepted their Letter of Selection will
		be done online through the ACT Raiders Club on My Sideline.
	b)	Players will be supplied with the appropriate link guiding them to register to the
		appropriate team along with a budget letter itemizing the components of the
		Player Levy set by TFACT and Alliance States Tour Agreement.
	c)	The player levy as set by TFACT administration will be payable through My
		Sideline and is compulsory payment for all athletes.
	d)	Where applicable extra costs such as and not limited to State Affiliation Fees and
		National One Fee membership may be applied.



	e)	All athletes are required to read, sign, and return the Alliance States Tour Agreement within the timeframe as set by TFACT.

	a)	A player or coach may withdraw from any position held within the ACT Raiders if they wish to do so.
	b)	Withdrawal is to be done in writing to Touch Football ACT, stating reasoning for withdrawal.
	c)	Where player levy and or uniform has been paid by the withdrawn, refund may be approved and processed by Touch Football ACT for all or part of the monies paid.

	a)	All athletes and Tour Staff are to wear the ACT Raiders Team Uniform as approved

	с)	Uniforms will conform to all TFA national regulations in their entirety. No uniform item will be permitted to be worn at any time that falls outside the national regulations or approval of TFACT.
	d)	Any athlete or staff member found to be in direct contravention of items 8a, 8b, or 8c may face disciplinary action as deemed suitable by TFACT.
	e)	All uniform purchases are to be made by athletes and tour staff online at time of registration to ACT Raiders club teams on My Sideline.
ltem 11 – P	Playing	Number Allocation.
	a)	Returning representative athletes may if allowable use their current playing singlet or top.
	b)	Where two numbers clash in any squad, a decision is to be made by athletes to purchase a new playing top.
	c)	Where new playing tops are purchased, TFACT reserves the right to issue new playing numbers as it sees fit to suit appropriate team composition.





	Players who are purchasing new tops will NOT be asked for any preferred number in line with item 9c.
e)	Where consented to by TFACT Mens and Womens Open squads may be excluded from items 9c and 9d.
Item 12 – Dispute	e Resolution and Appeal.
a)	Participants with grievances about the conduct of the selection process or seeking appeals on their non-selection must submit in writing through to the ACT State Manager within seven days of receiving notification of the selection outcome, along with any supporting evidence or information to support the grievance.
b)	All grievances and appeals will be considered by Touch Football ACT and noting the need for exclusion should there be any conflict of interest by any member. Touch Football ACT will then decide on the matter in accordance with TFA
c)	policies, in particular the Member Protection Policy. Touch Football ACT will inform the participant of the process used to consider the grievance or appeal and the outcome of the deliberations within 30 days of receiving the grievance or appeal decision.
d)	 Further grievances and appeals will be referred to Touch Football Australia for consideration and in this instance, complaints must be lodged in writing and must include: Complainant participant's name and telephone number Details of their complaint Steps taken with Touch Football ACT to have their complaint addressed, and any supporting documents and evidence of information.
